**JOINT RESOLUTION APPROVING ANNEXATION  
PORTIONS OF 19<sup>TH</sup> AVENUE NORTH &  
2 1/4 STREET NORTH RIGHTS OF WAY**

**WHEREAS**, a joint resolution for orderly annexation was adopted by the City of Sartell and the Town of LeSauk and duly accepted by the Minnesota Municipal Board; and

**WHEREAS**, said joint resolution requested that certain property be annexed to the City of Sartell pursuant to M.S. 414.0325, Subdivision 1; and

**WHEREAS**, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

**NOW, THEREFORE, BE IT RESOLVED:** That the following described property is hereby annexed to the City of Sartell, Minnesota, the same as if it had originally been made a part thereof:

The East 33.00 feet of the Northeast Quarter of Section 30;

The West 33.00 feet of the Northwest Quarter of Section 29;

The East 33.00 feet of the Southeast Quarter of Section 19;

The West 33.00 feet of the Southwest Quarter of Section 20;

The North 33.00 feet of the Southwest Quarter of Section 20;


The North 33.00 feet of the Northwest Quarter of the Southeast Quarter of Section 20, less and except that portion platted as CITY OF SARTELL RIGHT OF WAY PLAT NUMBER 1, according to the recorded plat thereof, on file and of record in the Office of the County Recorder, Stearns County, Minnesota.

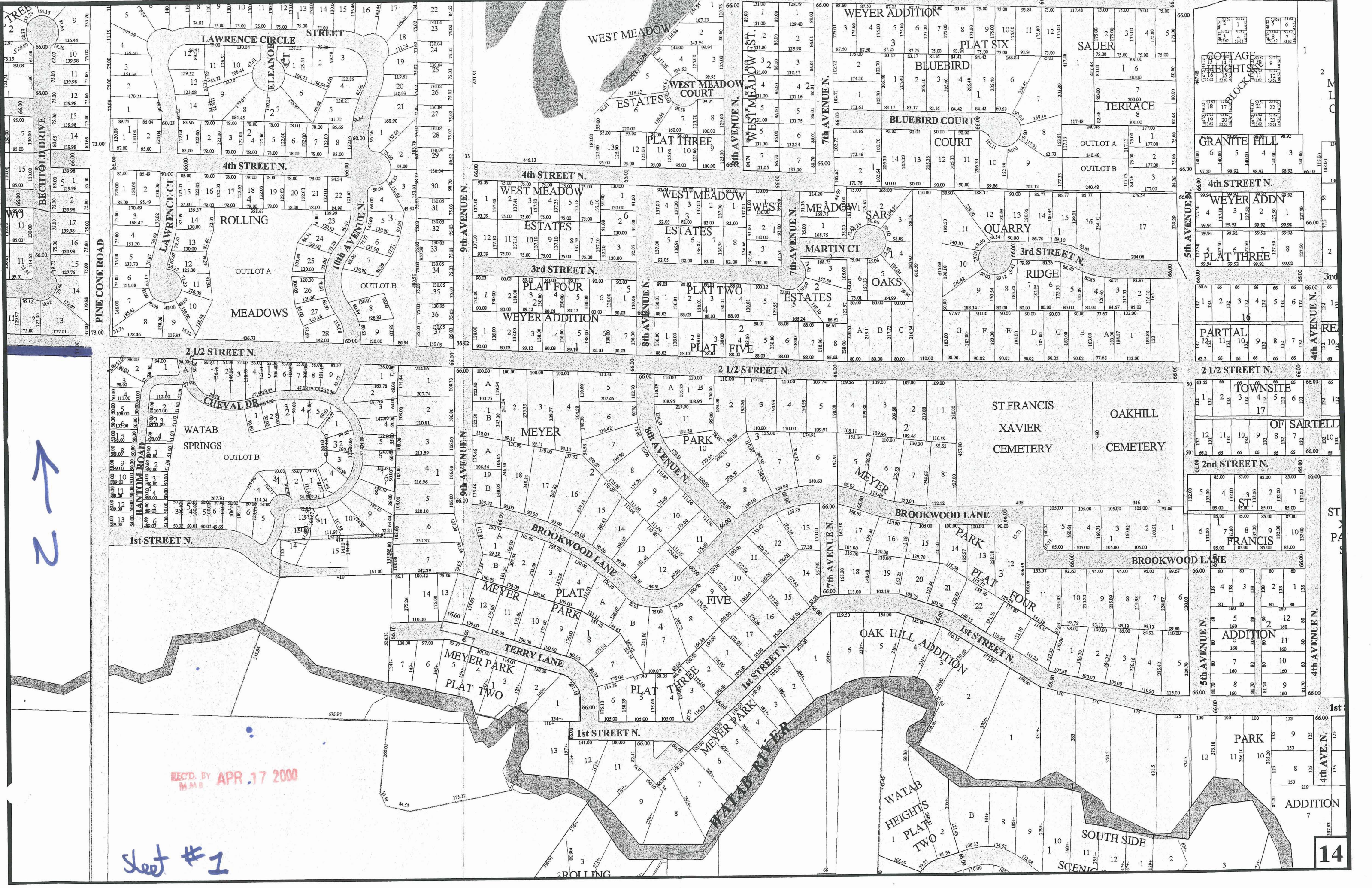

City Boundary

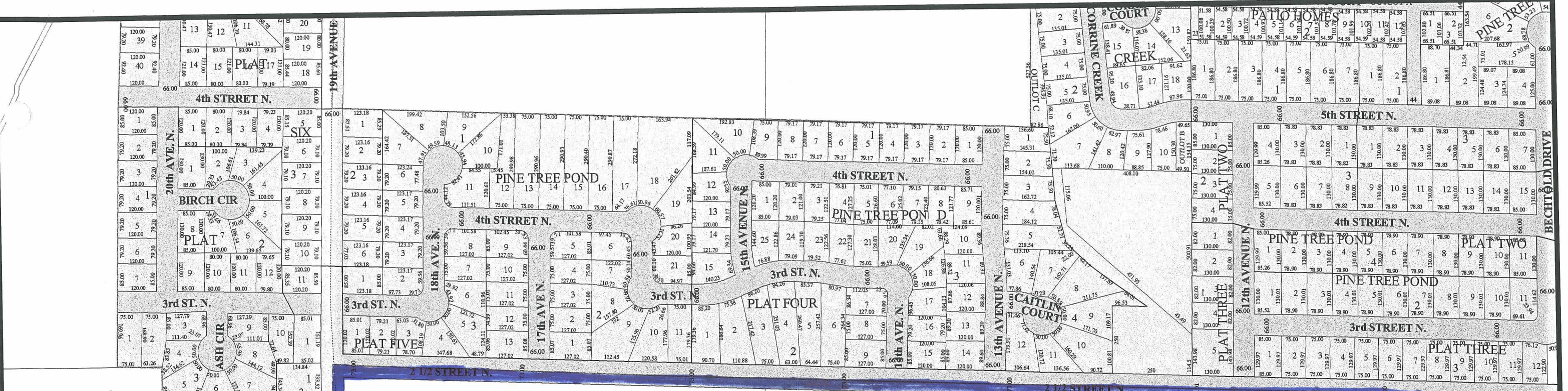
