# JOINT RESOLUTION APPROVING ANNEXATION $5^{\text{TH}}$ AVENUE SOUTH (FORMERLY $50^{\text{TH}}$ AVENUE) FROM COUNTY ROAD 119 SOUTH APPROXIMATELY 1353 FEET

The westerly 33.00 feet of the Southwest Quarter of the Southeast Quarter of Section 28, Township 125 North, Range 28 West, Le Sauk Township, Stearns County, Minnesota, lying southerly of the southerly right of way line of County Road Number 119.

The easterly 33.00 feet of the Northeast Quarter of the Northwest Quarter of Section 33, Township 125 North, Range 28 West, Le Sauk Township, Stearns County, Minnesota.

The westerly 33.00 feet of the northerly 66.00 feet of the Southwest Quarter of the Northeast Quarter of

Section 33, Township 125 North, Range 28 West, Le Sauk Township, Stearns County, Minnesota.

Containing 1.10 acres, more or less.

BE IT FURTHER RESOLVED: That said property is being annexed to the City of Sartell under zoning classification of R-1, Single Family Residence District, and has a current population of 0.
