JOINT RESOLUTION BETWEEN THE TOWN OF LESAUK AND THE CITY OF SARTELL AGREEING TO THE ANNEXATION OF RIGHT-OF-WAY NEEDED TO FACILITATE THE RECONSTRUCTION OF PINE CONE ROAD

NORTH IN ACCORDANCE WITH THE 1992 ORDERLY ANNEXATION AGREEMENT

WHEREAS, the Town of LeSauk (hereinafter the "Town") and the City of Sartell (hereinafter the "City") have determined that there is a need to immediately move forward to improve a portion of Pine Cone Road North to facilitate safe access to a proposed new elementary school site to an acceptable rural roadway design standard; and,

WHEREAS, the eventual improvement of that part of Pine Cone Road North to the new elementary school site as an urban section roadway will benefit abutting properties located within the Town, the patrons of the new elementary school site, and property owners within the City, School District and the Town that utilize that section of Pine Cone Road North; and,

WHEREAS, immediate annexation of the existing 66' wide corridor of right-of-way for Pine Cone Road North and 27th Street North between County Road 1 to Pine Cone Road North is necessary to enable these roadway sections to be designated and included in the funding eligibility as part of the city's Municipal State Aid System; and,

NOW, THEREFORE, BE IT RESOLVED by the Town Board and the City Council of Sartell that:

1. Immediate Annexation of Right-of-Way Corridor for Pine Cone Road North and $27^{\text {th }}$ Street North: Immediate annexation of the existing 66' wide right-of-way corridor for Pine Cone Road North from the northern limits of the City to 300 feet north of the northerly right-ofway line of 27 th Street North and the existing 66' wide right-of-way corridor for $27^{\text {th }}$ Street North from Pine Cone Road North to County Road 1 is approved. (Map and legal description as exhibits A \& B)
2. Agreement to Detach Annexed Right-of-Way: In the event that all required actions by the Town and Sartell City Council to implement the needed rural standard improvements to Pine Cone Road North do not occur by May 1, 2004, the Town agrees to a detachment action of the annexed right-of-way if initiated by adoption of a resolution by the Sartell City Council.
