JOINT RESOLUTION  
FOR ORDERLY ANNEXATION

The Township of Moose Lake and the City of Moose Lake hereby  
jointly agree to the following:

1. That the following described area in Moose Lake Township  
is subject to orderly annexation pursuant to Minnesota  
Statutes §414.0325, and the parties hereto designate this area for  
orderly annexation, to-wit:

North Half of Southwest Quarter ( $N\frac{1}{2}$  of  $SW\frac{1}{4}$ ) of Section  
Twenty-eight (28), Township Forty-six (46) North, of  
Range Nineteen (19) West.

North Half of Southeast Quarter ( $N\frac{1}{2}$  of  $SE\frac{1}{4}$ ), lying West  
of the right of way of Interstate Highway No. 35, of  
Section Twenty-eight (28), Township Forty-six (46) North,  
Range Nineteen (19) West.

South Half of Northeast Quarter ( $S\frac{1}{2}$  of  $NE\frac{1}{4}$ ), lying West  
of the right of way of Interstate Highway No. 35, of  
Section Twenty-eight (28), Township Forty-six (46) North,  
of Range Nineteen (19) West.

South Half of Southeast Quarter ( $S\frac{1}{2}$  of  $SE\frac{1}{4}$ ), lying West  
of the right of way of Interstate Highway No. 35, and  
~~South of the right of way of Highway 73,~~ of Section  
Twenty-eight (28), Township Forty-six (46) North, of  
Range Nineteen (19) West.

West Half of Northeast Quarter ( $W\frac{1}{2}$  of  $NE\frac{1}{4}$ ), lying West of  
the right of way of Interstate Highway No. 35, of Section  
Thirty-three (33), Township Forty-six (46) North, of  
Range Nineteen (19) West.

2. That the Township Board of the Township of Moose Lake,

and the City Council of the City of Moose Lake, upon passage and adoption of this Resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in this agreement.

3. That these properties which abut the City of Moose Lake are presently urban or suburban in nature or are about to become so. Further, the City of Moose Lake is capable of providing services to this area within a reasonable time, and the annexation is in the best interest of the area proposed for annexation. Therefore, these properties would be immediately annexed to the City of Moose Lake. The area is described as follows:

North Half of Southwest Quarter ( $N\frac{1}{2}$  of  $SW\frac{1}{4}$ ) of Section Twenty-eight (28), Township Forty-six (46) North, of Range Nineteen (19) West.

North Half of Southeast Quarter ( $N\frac{1}{2}$  of  $SE\frac{1}{4}$ ), lying West of the right of way of Interstate Highway No. 35, of Section Twenty-eight (28), Township Forty-six (46) North, Range Nineteen (19) West.

South Half of Northeast Quarter ( $S\frac{1}{2}$  of  $NE\frac{1}{4}$ ), lying West of the right of way of Interstate Highway No. 35, of Section Twenty-eight (28), Township Forty-six (46) North, of Range Nineteen (19) West.

South Half of Southeast Quarter ( $S\frac{1}{2}$  of  $SE\frac{1}{4}$ ), lying West of the right of way of Interstate Highway No. 35, and South of the right of way of Highway 73, of Section Twenty-eight (28), Township Forty-six (46) North, of Range Nineteen (19) West.


West Half of Northeast Quarter ( $W\frac{1}{2}$  of  $NE\frac{1}{4}$ ), lying West of the right of way of Interstate Highway No. 35, of Section Thirty-three (33), Township Forty-six (46) North, of Range Nineteen (19) West.

4. Both the Township of Moose Lake and the City of Moose Lake agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no


consideration by the Municipal Board is necessary. Upon receipt of this Resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.



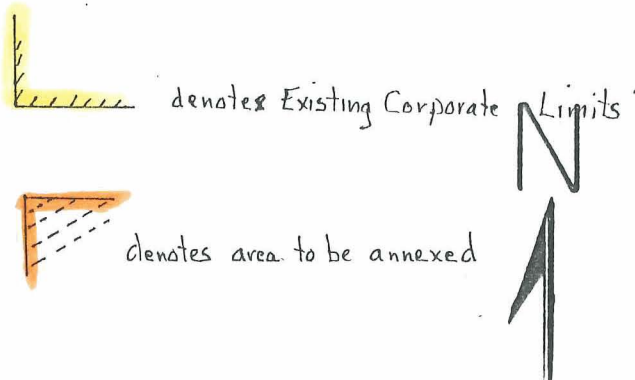
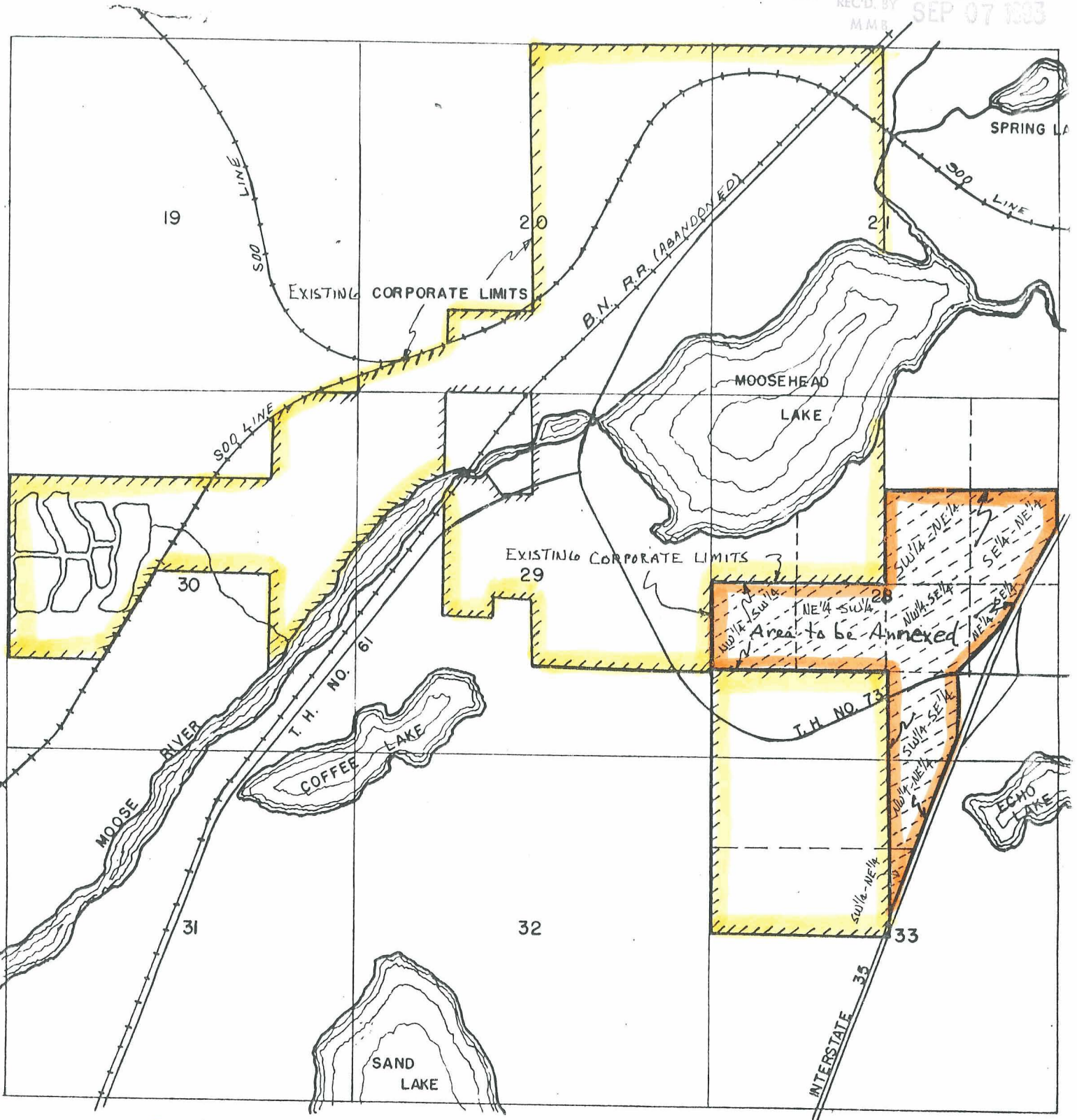
