North Half of Southwest Quarter  $(N\frac{1}{2} \text{ of } SW\frac{1}{4})$  of Section Twenty-eight (28), Township Forty-six (46) North, of Range Nineteen (19) West.

North Half of Southeast Quarter  $(N\frac{1}{2} \text{ of } SE\frac{1}{4})$ , lying West of the right of way of Interstate Highway No. 35, of Section Twenty-eight (28), Township Forty-six (46) North, Range Nineteen (19) West.

South Half of Northeast Quarter ( $S_{2}^{1}$  of NE<sub>4</sub>), lying West of the right of way of Interstate Highway No. 35, of 9303770 Section Twenty-eight (28), Township Forty-six (46) North, of Range Nineteen (19) West.

South Half of Southeast Quarter  $(S^{\frac{1}{2}} \text{ of } SE^{\frac{1}{4}})$ , lying West of the right of way of Interstate Highway No. 35, and South of the right of way of Highway 73, of Section Twenty-eight (28), Township Forty-six (46) North, of Range Nineteen (19) West.

West Half of Northeast Quarter  $(W_2^{1} \text{ of } NE_4^{1})$ , lying West of the right of way of Interstate Highway No. 35, of Section Thirty-three (33), Township Forty-six (46) North, of Range Nineteen (19) West.
