

IN THE MATTER OF THE JOINT
RESOLUTION OF THE CITY OF
NASHWAUK AND THE TOWN OF
LONE PINE DESIGNATING AN
UNINCORPORATED AREA AS IN NEED
OF ORDERLY ANNEXATION AND
CONFERRING JURISDICTION OVER
SAID AREA TO THE MINNESOTA
MUNICIPAL BOARD PURSUANT TO
MINN. STAT. 414.0325

JOINT RESOLUTION FOR ORDERLY
ANNEXATION

The Township of Lone Pine and the City of Nashwauk hereby
jointly agree to the following:

1. That the following described area in Line Pine Township
is subject to orderly annexation pursuant to Minnesota Statutes
414.0325.

That Part of Government Lot 1, Section 6, Township 56,
Range 22, lying North and West of Highway No. 169
and State Highway No. 65

2. That the Town Board of Lone Pine Township, and the City
Council of the City of Nashwauk, upon passage and adoption of this
Resolution and upon the acceptance by the Municipal Board, confer
jurisdiction upon the Municipal Board over the various provisions
contained in this Resolution.

3. That this certain property which abuts the City of
Nashwauk is presently urban and suburban in nature or about to
become so. The usable portion of this property is commercial and
presently used as a bulk gas and fuel oil storage area; the
balance of the property is an old mine dump. The mine dump
effectively separates the usable portion of the property from Lone
Pine Township. The usable portion of the property abuts the City
of Nashwauk. Further, the City of Nashwauk is capable of
providing services to this area within a reasonable time, and the
annexation is in the best interests of the area proposed for
annexation. Therefore, these properties as set forth in paragraph
1 would be immediately annexed to the City of Nashwauk.

4. Both the City of Nashwauk and the Town of Lone Pine agree
that no alteration of the stated boundaries of this Agreement is
appropriate. Furthermore, each party agrees that no consideration
by the Municipal Board is necessary. Upon receipt of this
Resolution, passed and adopted by each party, the Municipal Board
may review and comment, but shall, within 30 days, order the
annexation in accordance with the terms of this Joint Resolution.

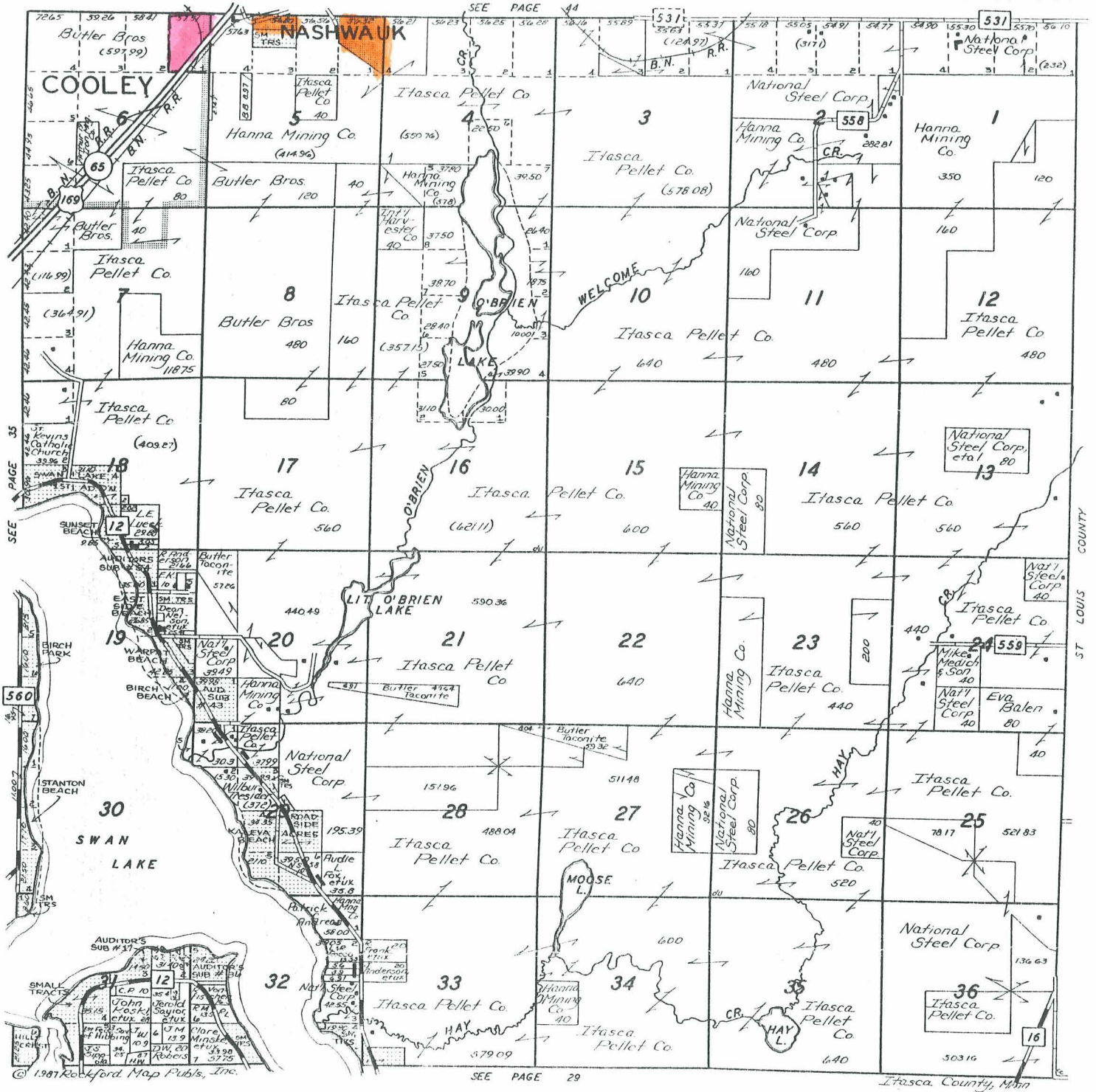

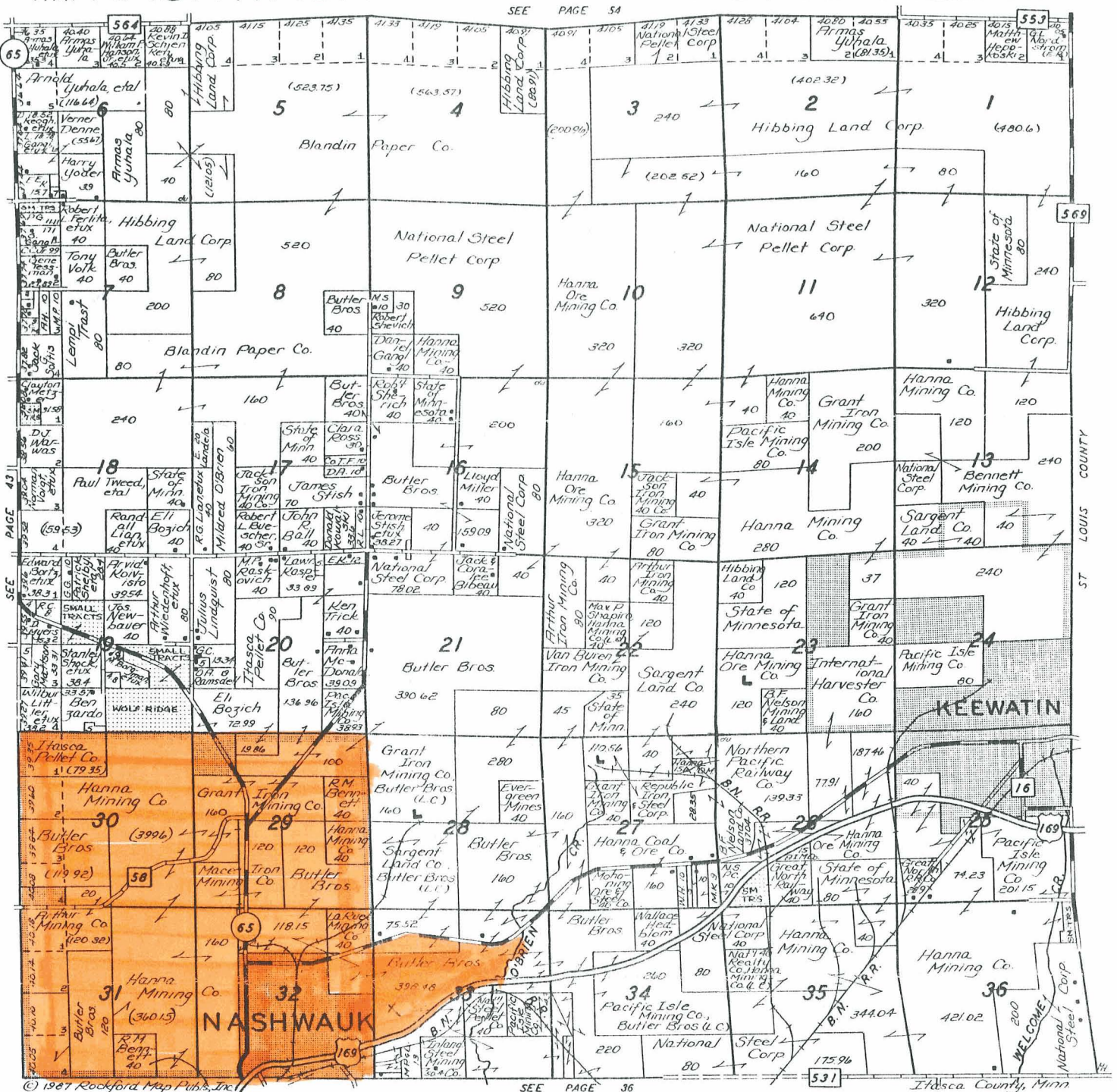
