RESOLUTION OF THE CITY OF MANKATO  
APPROVING ANNEXATION PER JOINT ORDERLY ANNEXATION  
AGREEMENT WITH MANKATO TOWNSHIP

WHEREAS, a petition has been submitted by the owners of property located in Section 9, Township 108 North, Range 26 West, requesting that said described property on the petition be annexed to the City of Mankato; and

WHEREAS, there are 0 residents living on said property; and

WHEREAS, Mankato Township has passed a resolution of no objection to this annexation; and

WHEREAS, the Council of the City of Mankato finds that it is in the best interest of the City to support such annexation.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of Mankato, Minnesota, hereby states that the City has no objection to the annexation of the following described property per M.S. 414.0325 and the joint resolution for orderly annexation approved by Mankato Township and the City of Mankato:

TRACT A: All that part of the North 12-1/3 acres of the South 26-2/3 acres of the Southeast Quarter of the Northeast Quarter (SE 1/4 NE 1/4) Section 9, Township 108 North, Range 26 West, which lies north of the right-of-way of U.S. Highway 14, Blue Earth County, Minnesota. Containing 3.03 acres, more or less, currently owned by James A. Sohler and Betty A. Sohler, also known as Elizabeth A. Sohler.

AND

TRACT B: The Northeast Quarter of the Northeast Quarter and the North 13-1/3 acres of the Southeast Quarter of the Northeast Quarter of Section 9, Township 108, Range 26 West, Blue Earth County, Minnesota. Excepting therefrom 2.66 acres transferred to the State of Minnesota under deed dated December 2, 1974 and recorded on December 12, 1974 at 4:35 p.m. in 231 Blue Earth County Records at page 180. Containing 50.76 acres more or less. Currently owned by Simon Sohler, Jr., also known as Simon Sohler and Dorothy Sohler.

This resolution shall become effective immediately upon its passage and without publication.
