MUNICIPAL BOARD PURSUANT TO
M.S. 414.0325

JOINT RESOLUTION
OF ORDERLY ANNEXATION

The Township of Crow Lake and the City of Brooten hereby jointly
agree to the following:

1. That the following described area in Crow Lake Township is
subject to orderly annexation pursuant to Minnesota Statutes
414.0325, and the parties hereto designate this area for orderly
annexation, to wit:

Those Southeasterly parts of lots 3, 4, and 5, Block 3, Foote
Subdivision lying in Crow Lake Township.

2. That the Town Board of Crow Lake Township, and the City
Council of the City of Brooten, upon passage and adoption of this
resolution and upon the acceptance by the Municipal Board, confer
jurisdiction upon the municipal Board over the various provisions
contained in this Agreement.

3. That these certain properties which abut the City of Brooten
are presently urban or suburban in nature or are about to become
so. Further, the City of Brooten is capable of providing
services to this area within a reasonable time, and the
annexation is in the best interest of the area proposed for
annexation. Therefore, these properties would be immediately
annexed to the City of Brooten, to wit:

Those Southeasterly parts of lots 3, 4, and 5, Block 3, Foote
Subdivision lying in Crow Lake Township.

4. Upon annexation, the City shall zone the annexed parcels Residential Single Family.

5. Both Crow Lake Township and the City of Brooten agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.
