AGREEMENT BETWEEN THE CITY OF)	<u>ORDER</u>
LINDSTROM AND THE TOWN OF CHISAGO LAKE)	
PURSUANT TO MINNESOTA STATUTES 414)	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Lindstrom and the Town of Chisago Lake; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Lindstrom pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 7, 1997, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Lindstrom, Minnesota, the same as if it had originally been made a part thereof:

The North ½ of the Northwest 1/4 of Section 9, Township 33 Range 20, except the portion thereof previously platted. All in Chisago Lake Township,


Chisago County, Minnesota, AND the South ½ of the Southwest 1/4 of ~~Lot 4~~ in Section 4, and Government Lot 1 in Section 4, Township 33, Range 20, which lies Westerly of CSAH #25, except the westerly 475 feet of the northerly 230 feet thereof, except that part of Government Lot 1 described as follows: Beginning at the South 1/4 corner of said Section 4; thence South 89 degrees, 53 minutes, 12 seconds East assumed bearing along the South line of said Section 4, a distance of 703.79 feet to the point of beginning; thence north 89 degrees, 53 minutes, 12 seconds west, retracing along said South line a distance of 173 feet; thence North 27 degrees, 21 minutes, 8 seconds east, a distance of 790.62 feet; thence north 0 degrees, 30 minutes, 20 seconds east, a distance of 624.78 feet to the northerly line of Government Lot 1; thence easterly, along said North line a distance of 290 feet, more or less, to the center line of Olinda Trail, thence southerly along said center line to its intersection with a line that bears North 85 degrees, 39 minutes, 47 seconds east from the point of beginning; thence southerly 85 degrees, 39 minutes, 47 seconds west, a distance of 730 feet more or less to the point of beginning. All in Chisago Lake Township, Chisago County, Minnesota.

IT IS FURTHER ORDERED: That the effective date of this order is March 7, 1997.

IT IS FURTHER ORDERED: That the effective date of this amended order is August 27, 1998.
