

A RESOLUTION ANNEXING LAND OWNED BY SIMPSON

WHEREAS, a request was received from the Simpson's to annex part of the East half of the Southwest Quarter (E1/2, SW1/4) of Section 13, T36N, r31W, Benton County, Minnesota, and

WHEREAS, a public hearing was held on this date at which time all persons desiring to be heard were given an opportunity, and

WHEREAS, the Sauk Rapids Joint Planning Board, and the Sauk Rapids Planning Commission have reviewed and recommended the annexation, and

WHEREAS, the City Council, the Township Board and the property owner all agree to the annexation.

NOW THEREFORE BE IT RESOLVED BY THE SAUK RAPIDS CITY COUNCIL THAT:

1. The following described property is hereby annexed:


The East 208 feet of the North 200 feet of the South 1564 feet of the East half of the Southwest Quarter (E1/2 SW1/4) of Section Thirteen (13), Township Thirty-six (36) North, Range Thirty-one (31) West, Fourth Principal Meridian, Benton County, Minnesota, being more particularly described as follows, to wit:


Beginning at a point on the East line of the Southwest Quarter (SW1/4) of Section Thirteen (13), Township Thirty-six (36) North, Range Thirty-one (31) West, said point being 1364 feet North of the Southeast corner of said Southwest Quarter (SW1/4); thence continue North on said East line of said Southwest Quarter (SW1/4) 200 feet; thence West at right angles 208 feet; thence South at right angles 200 feet; thence East at right angles 208 feet to the point of beginning, subject to Township road right-of-way.

2. That the quantity of land described above is approximately 0.96 acres.
3. In accord with MSA 414.0325 and the existing Orderly Annexation Agreement between the City of Sauk Rapids and Sauk Rapids Township, the Minnesota Municipal Boundary Adjustments is asked to approve the annexation.
