

IN THE MATTER OF THE JOINT
RESOLUTION OF THE TOWN OF
LAKE SHORE AND THE CITY
OF LOUISBURG DESIGNATING
AN UNINCORPORATED AREA AS
IN NEED OF ORDERLY ANNEXATION
AND CONFERRING JURISDICTION
OVER SAID AREA TO THE MINNESOTA
MUNICIPAL BOARD PURSUANT
TO MINNESOTA STATUTES 414.0325

JOINT RESOLUTION
FOR ORDERLY ANNEXATION

The Township of Lake Shore and the City of Louisburg hereby jointly agree to
the following:

1. That the following described area in Lake Shore Township is subject to
orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties
hereto designate this area for orderly annexation, to wit:

Beg. 198 ft West of SE Cor SW 1/4 SE1/4, North 165 ft, West 125 ft, South 165
ft, East to beg 28-120-44 being .50 Acres more or less.

2. That the Town Board of the Township of Lake Shore, and the City
Council of the City of Louisburg, upon passage and adoption of this Resolution
and upon the acceptance by the Municipal Board, confer jurisdiction upon the
Municipal Board over the various provisions contained in this Agreement.

3. That this certain property which is adjacent to the the City of Louisburg
is presently urban or suburban in nature or is about to become so. Further, the
City of Louisburg is capable of providing services to this area within a reasonable
time, and the annexation is in the best interest of the area proposed for
annexation.

4. It is therefore agreed that the following property be immediately
annexed to the City of Louisburg, to wit:

Beg. 198 ft West of SE Cor SW1/4 SE1/4, North 165 ft, West 125 ft, South 165 ft, East to beg 28-120-44 being .50 Acres more or less.


5. Upon annexation, the City shall zone said property Noncentral Business District.

6. Both Lake Shore Township and the City of Louisburg agree that no alteration of the stated boundaries of this Agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this Resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint Resolution.
