That part of the Southeast Quarter and Southwest Quarter of Section 18, Township 121, Range 24, Wright County, Minnesota described as follows:

Commencing at the South 1/4 corner of Section 18, Township 121, Range 24, thence along the east line of outlot F, Meadow Oak Addition on an assumed bearing of N 1°10'00" E, a distance of 1586.01 feet, to the southerly right-of-way line of the Burlington Northern Railroad; thence S 49°56'47" E, along the southerly right-of-way line of the Burlington Northern Railroad, a distance of 754.22 feet; thence S 39°58'44" W, a distance of 333.32 feet; thence S 1°10'00" E, a distance of 263.77 feet;

thence S 37°52'23" W, a distance of 76.22 feet;

thence S 0°12'16" E, a distance of 295.00 feet;

thence S 8°36'13" W, a distance of 60.72 feet;

thence S $0^{\circ}12'16''$ E, a distance of 165.00, to the south line of the Southeast 1/4 of Section 18, Township 121, Range 24; thence along the south line of the Southeast 1/4 of Section 18 along an assumed bearing of S $89^{\circ}47'44''$ W, a distance of 282.00 feet to the point of beginning.

Said Parcel containing 11.892 acres more or less.

The Town of Monticello and the City of Monticello hereby jointly agree that the joint resolution between the Town of Monticello and the City of Monticello designating an area for orderly annexation dated March 6, 1998, be amended to include the following:

PARKSIDE AT MEADOW OAK:

That part of the Southeast Quarter of Section 18; Township 121, Range 24, Wright County, Minnesota lying southerly of the Burlington Northern Railroad and westerly and northwesterly of the following described line; Commencing at the South Quarter corner of said Section 18; thence northeasterly along the south line of said Southeast Quarter on an assumed bearing of North 89 degrees 47 minutes 44 seconds East a distance of 282.00 feet to the point of beginning of the line to be described; thence North 00 degrees 12 minutes 16 seconds West a distance of 165.00 feet; thence North 8 degrees 36 minutes 13 seconds East a distance of 60.72 feet; thence North 00 degrees 12 minutes 16 seconds West a distance of 295.00 feet; thence North 37 degrees 52 minutes 23 seconds East a distance of 76.22 feet; thence North 1 degree 10 minutes 00 seconds West a distance of 263.77 feet; thence North 39 degrees 58 minutes 44 seconds East a distance of 333.32 feet to a point on the southwesterly right of way line of said Burlington Northern Railroad, said point being 754.22 feet southeasterly of the intersection of the said southwesterly right of way and the east line of Outlot F in the duly recorded plat of Meadow Oak, Wright County, Minnesota.

Also that part of the Southwest Quarter of Section 18, Township 121, Range 24 lying southerly of the Burlington Northern Railroad and easterly of Outlot F and Outlot K in the duly recorded plat of Meadow Oak, Wright County, Minnesota.




