WHEREAS, resolutions were received from the City of Big Lake and the Town of Big Lake indicating their desire that certain property be annexed to the City of Big Lake pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on October 13, 2003, the Acting Director has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the resolution to the City of Big Lake, Minnesota, the same as if it

## had originally been made a part thereof:

# PROPOSED LEGAL DESCRIPTION FOR ANNEXATION (MITCH K FARMS)

That part of the Southwest Quarter of the Southeast Quarter of Section 7, Township 33, Range 27, Sherburne County, Minnesota, lying west of the Elk River and lying northerly of the following described line: Commencing at the South Quarter corner of said Section 7; thence North 0 degrees 06 minutes 00 seconds East, assumed bearing, along the West line of the Southwest Quarter of the Southeast Quarter of said Section 7, a distance of 450.00 feet to the point of beginning of the line to be described; thence North 75 degrees 32 minutes 05 seconds East, a distance of 170.00 feet, more or less, to the thread of the Elk River and there terminating said line.

#### AND

The Southwest Quarter of Section 7, Township 33, Range 27, Sherburne County, Minnesota, except the following parcels:

## Exception No. 1:

Those parts of the Northeast Quarter of the Southwest Quarter of said Section 7 lying north of the Elk River.

## Exception No. 2:

The joint resolution does not make reference to which of the three statutory provisions the parties have agreed on to govern planning in the designated area.

The parties are encouraged to consider this comment in light of any further amendments that may be otherwise necessary to this agreement for orderly annexation.
