## JOINT RESOLUTION FOR ORDERLY ANNEXATION

The Township of Cokato and the City of Cokato hereby jointly agree to the following:

- 1. That the following described area in Cokato Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parities hereto designate this area for orderly annexation, to wit:
  - The Southeast Quarter of the Northwest Quarter of Section 27, Township 119, Range 28, Wright County, Minnesota
- 2. That the Town Board of the Township of Cokato, and the City Council of the City of Cokato, upon passage and adoption of this Resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in this Agreement.
- 3. That these certain properties which abut the City of Cokato are presently urban or suburban in nature or are about to become so. Further, the City of Cokato is capable of providing services to this area within a reasonable time, and the annexation is in the best interest of the area. Therefore, this property would be immediately annexed to the City of Cokato two wit:
  - The Southeast Quarter of the Northwest Quarter of Section 27, Township 119, Range 28, Wright County, Minnesota
- 4. Upon Annexation, the City shall zone the parcel as Residential "R2" District.
- 5. Both the Town of Cokato and the City of Cokato agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this Resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.






