JOINT RESOLUTION FOR ORDERLY ANNEXATION

**TO: MUNICIPAL BOUNDARY ADJUSTMENTS
C/O MINNESOTA PLANNING
658 CEDAR STREET
ST. PAUL, MINNESOTA 55155**

WHEREAS, the City of St. Paul Park (hereinafter the "City") and Grey Cloud Island Township (hereinafter the "Township") are in agreement as to the orderly annexation of the following described real property, to wit:

(see exhibit A attached)

WHEREAS, the above described area is situated within the Township and is about to become urban or suburban in character and that the City is capable of providing the municipal services required by said area within a reasonable time;

WHEREAS, the Township form of government is not adequate to protect the public health, safety and welfare within said area;

WHEREAS, annexation of the area by the City would be in the best interest of the area;

WHEREAS, orderly annexation will benefit the residents and the owners of the area and permit the City to extend necessary municipal services to the area in a planned and efficient manner.

WHEREAS, pursuant to Minn. Stat. §414.0325 the City and Township agree upon the orderly annexation of the area hereinbefore described; and

WHEREAS, the City and Township have agreed herein upon the conditions for the annexation of said area and that no consideration of Minnesota Planning is necessary prior to the orderly annexation provided herein.

NOW, THEREFORE, BE IT RESOLVED JOINTLY by the City and Township as follows:

1. That the following described area is subject to orderly annexation pursuant to Minn. Stat. §414.0325, to wit:

(See Exhibit A attached)

2. That the Township does, upon passage of this Joint Resolution, its adoption by the City Council, and acceptance by Municipal Planning, confer jurisdiction so as to effect an orderly annexation in accordance herewith.
3. That the area is contiguous with and abuts the City along the Township's northerly and northeasterly boundaries; said area is about to be urban or suburban in character; the City is capable of providing municipal services to the area within a reasonable time; and annexation would be in the best interest of the area.
4. That the provisions of Minn. Stat. §414.0325, Subd. 1(a), captioned "Electric Utility Service Notice" are not applicable.
5. That the Township and the City agree that no consideration by Municipal Planning is necessary and that upon receipt this joint resolution passed and adopted by each of the parties hereto, Municipal Planning may review and comment but shall order annexation within thirty (30) days in compliance with the terms and conditions herein.
6. That there is currently pending before Minnesota Planning the following contested matters, to wit:

In Re: Petition for Municipal Boundary Adjustments:
St. Paul Park, Grey Cloud Island Township (A-6185)
Cottage Grove, Grey Cloud Island Township (A-6186)

That the Township and City jointly request that said matters be dismissed with prejudice with costs and disbursements allocated as determined therein.

EXHIBIT A

Beginning at the intersection of the centerline of County Road 75 (being also known as Third Street and Division No. 4 of St. Paul Park and also being known as Grey Cloud Island Drive) with the extension Westerly of the South lot line of Lot 18, Block 117, Division No. 4 of St. Paul Park, thence Southerly along the centerline of said County Road 75 to its intersection with the centerline of Grey Cloud Trail; thence South and Easterly along the centerline of said Grey Cloud Trail until its intersection with the East Boundary line of Grey Cloud Island Township; thence Northerly along said Eastern boundary line to its point of intersection with the boundary line of the City of St. Paul Park; thence Westerly on the common boundary between the City of St. Paul Park and Grey Cloud Island Township to the Westerly right-of-line of the Burlington Northern Railroad (being also known as the common boundary between the City of St. Paul Park and Grey Cloud Island Township); thence Northwesterly along said common boundary line to its intersection with the South line of Block 113, Division No. 4 of St. Paul Park extended Easterly; then Westerly along the South lines of Blocks 113, 114, 115, 116 and 117, Division No. 4 of St. Paul Park extended Westerly to its intersection with County Road 75 and there terminating (being all within the Township of Grey Cloud Island, Washington County, Minnesota).
