IN THE MATTER OF THE ORDERLY ANNEXATION

WHEREAS, Reorganization Order No. 192, effective March 8, 2005, has transferred the duties of the Director to the Chief Administrative Law Judge; and

WHEREAS, on May 11, 2006, the Chief Administrative Law Judge has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Rockford, Minnesota, the same as if it had originally been made a part thereof:

Phase Three: Joseph Wells

That part of the Northwest Quarter of the Southeast Quarter and the West Half of the East Half of the Southeast Quarter, all in Section 30, Township 119, Range 24, Wright County, Minnesota, described as follows:

Commencing at the southeast corner of said Northwest Quarter of the Southeast

In ordering the annexation contained in Docket No. OA-824-2, the Chief Administrative Law Judge finds and makes the following comment:

In the section of the agreement entitled "6. Upon annexation", the agreement imposes a financial obligation on the property owner of the subject property to reimburse the Township for lost tax revenue. Chapter 414 of Minnesota Statutes contains no authority for the imposition of this nature on the property owner as part of a boundary adjustment.

The parties are encouraged to consider this comment in light of any further amendments that may be otherwise necessary to this agreement for orderly annexation.
