### **JOINT RESOLUTION FOR ORDERLY ANNEXATION**

***IN THE MATTER OF THE JOINT RESOLUTION OF THE CITY OF  
ROSE CREEK AND WINDOM TOWNSHIP DESIGNATING AN  
UNINCORPORATED AREA AS IN NEED OF ORDERLY  
ANNEXATION AND CONFERRING JURISDICTION OVER SAID  
AREA TO THE MINNESOTA MUNICIPAL BOARD PURSUANT TO  
M.S. 414.0325.***

*THE CITY OF ROSE CREEK AND WINDOM TOWNSHIP HEREBY JOINTLY AGREE TO  
THE FOLLOWING:*

*1. That the following described area in Windom Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to wit:*

- THAT PART OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 35, TOWNSHIP 102 NORTH, RANGE 17 WEST, MOWER COUNTY, MINNESOTA, DESCRIBED AS FOLLOWS:*
- CERTIFIED DESCRIPTION ATTACHED.*

*2. That the Town Board of Windom Township, and the City Council of the City of Rose Creek, upon passage and adoption of this resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in this Agreement.*

3. Both Township and the City of Rose Creek agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each part, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.

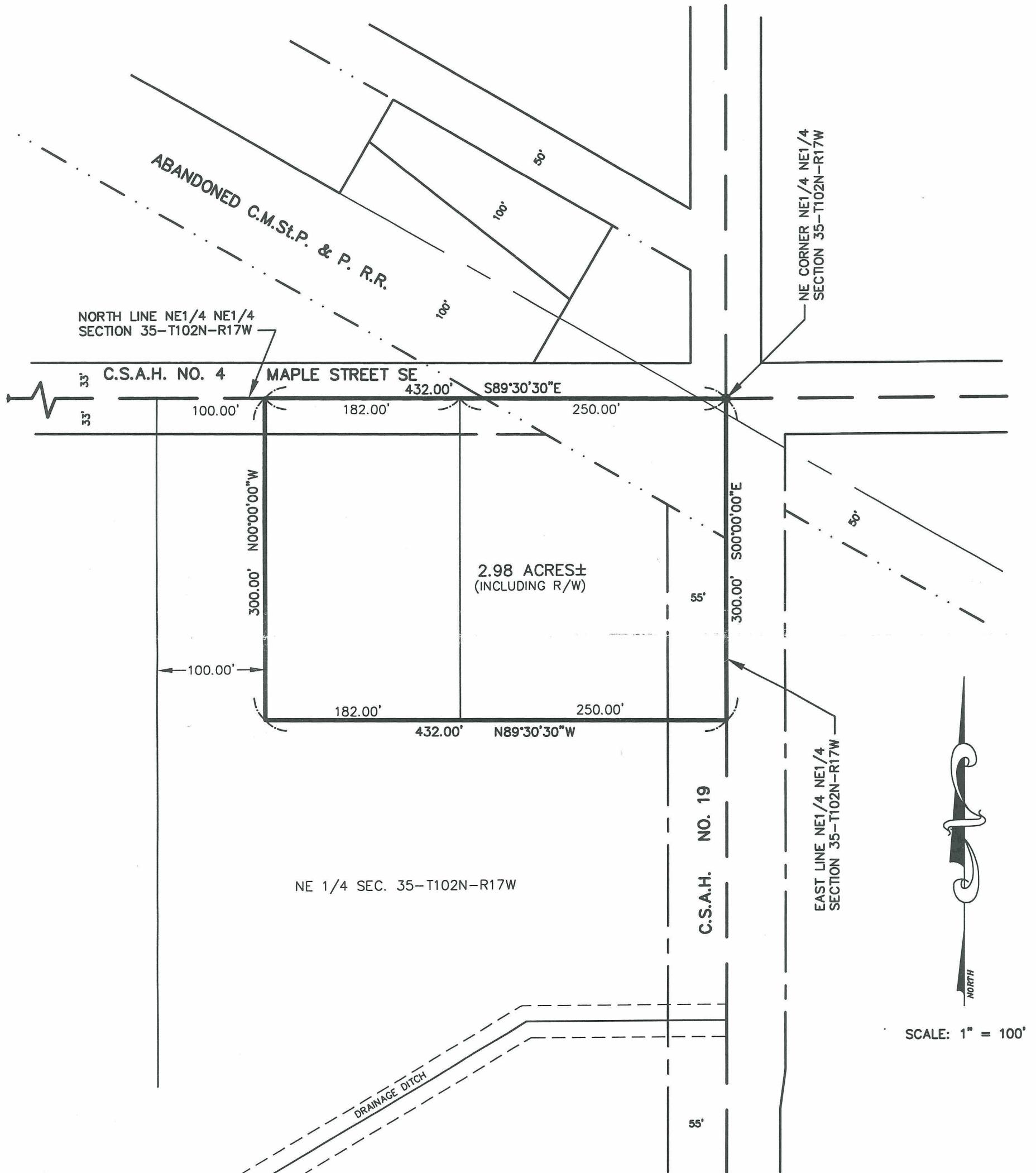
