ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Watertown and the Town of Watertown; and

WHEREAS, a resolution was received from the City of Watertown and the Town of Watertown indicating their desire that certain property be annexed to the City of Watertown pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325, M.S. 414.11, and M.S. 414.12 states that in certain

circumstances the Director of the Office of Strategic and Long Range Planning may review and

comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on October 11, 2002, the Director of the Office of Strategic and Long Range Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in

accordance with the terms of the joint resolution to the City of Watertown, Minnesota, the same

as if it had originally been made a part thereof:

Parcel 1

The Southeast Quarter of the Southeast Quarter of Section 8 in Township 117 North of Range 25 West.

A parcel of land situated in the Southwest Quarter of the Southwest Quarter of Section 9,

Township 117, Range 25, and more particularly described as follows: Commencing at the Southwest corner of Section 9, Township 117, Range 25; thence running East on the South section line of said Section 9 a distance of 220 feet; thence North on a line parallel with the section line between Sections 8 and 9 a distance of 367.125 feet; thence West on a line parallel with the South section line of Section 9 a distance of 220 feet to the section line between Sections 8 and 9; thence South on said section line a distance of 367.125 feet to the point of beginning.

Parcel 2

The North 17.57 acres of that part of the Southwest Quarter of the Southwest Quarter of Section 9 in Township 117 North of Range 25 West that lies West of the center line of the public road as it is now established. EXCEPT, the South 325 feet of the North 17.57 acres of that part of the Southwest Quarter of the Southwest Quarter of Section 9 in Township 117 North of Range 25 West that lies West of the center line of the public road as it is now established.

Parcel 3

The South 325 feet of the North 17.57 acres of that part of the Southwest Quarter of the Southwest Quarter of Section 9 in Township 117 North, Range 25 West, lying West of the centerline of the public road as it is now established.

Except any part of the above-described parcels presently within the corporate limits of the City of Watertown.
