WHEREAS, a joint resolution for orderly annexation was adopted by the City of  
Goodview and the Town of Rollingstone; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of  
Goodview pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic  
and Long Range Planning may review and comment, but shall within 30 days order the annexation  
of land pursuant to said subdivisions; and

WHEREAS, on July 18, 2003, the Acting Director has reviewed and accepted the  
resolution for orderly annexation;


IT IS HEREBY ORDERED: That the following described property is hereby annexed in  
accordance with the terms of the joint resolution to the City of Goodview, Minnesota, the  
same as if it had originally been made a part thereof:

Commencing at the Southwest corner of the Southwest Quarter of the Northwest Quarter  
of said Section 12, Township 107, Range 8, thence in an easterly direction and along the  
south line of the Southwest Quarter of the Northwest Quarter of said section 12 for a

distance of 1328.4 feet to the center line of the township road, thence deflect to the left 126 degrees, 58 minutes for a distance of 608.2 feet, thence deflect to the left 9 degrees, 9 minutes for a distance of 117.25 feet to the point of beginning, thence deflect to the left 88 degrees, 4 minutes, 30 seconds for a distance of 130 feet, thence deflect to the right 73 degrees, 17 minutes for a distance of 250.65 feet, thence deflect to the right 83 degrees, 27 minutes, 30 seconds for a distance of 208.1 feet to the center line of the township road, thence deflect to the right 111 degrees, 20 minutes and along the center line of the township road for a distance of 322.32 feet, more or less, to the point of beginning excepting therefrom the right of way of the township road.
